

PARENT'S INDEMNIFICATION AND RELEASE

As used herein, the term "Owner(s) and Operator(s) of Fields & Fences" shall include American National Bank and Trust Company of Chicago, not personally but as Trustee under Trust No. 120012-02; Fields & Fences Equestrian Center, Inc., an Illinois Corporation; Fields & Fences School of Horsemanship, Inc.; Anita Schadeck; and all of their beneficiaries, shareholders, directors, officers, partners, agents, independent contractors, and employees.

The undersigned, being of lawful age and in their capacity as parent and/or legal guardian of _____ (the "Minor"), desires to allow the Minor to enter upon the premises of the Owner(s) and Operator(s) of Fields & Fences, located at the southwest corner of Hunt Club Road and Stearns School Road, Wadsworth, Illinois to use horses and the facilities either owned or controlled by the Owner(s) and Operator(s) of Fields & Fences, **AND BEING DULY AWARE OF THE RISK OF INJURY AND HAZARDS INHERENT UPON ENTERING UPON SAID PREMISES AND/OR THE RIDING OF HORSES**, hereby elects voluntarily to allow the Minor to enter upon said premises and to participate in said hazardous activities. For the consideration recited below, the undersigned further expressly understands and agrees to indemnify, defend and hold the Owner(s) and Operator(s) of Fields & Fences harmless against any and all claims or damages, costs or expenses incurred by them (including but not limited to attorney's fees and costs), as a result of any accident, injury or property loss which may occur while the Minor is upon said premises or is engaged in said activities and which may result from the negligence of the Minor, the Owner(s) and Operator(s) of Fields & Fences, and their employees, agents, third parties or any combination thereof.

The undersigned, for and in consideration of granting the Minor permission to enter upon said premises, ride said horses and/or participate in equestrian activities, including but not limited to lessons, shows and other equestrian events (and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged), **do hereby voluntarily RELEASE the Owner(s) and Operator(s) of Fields & Fences of ALL RISKS OF LOSS OR INJURY that might be sustained on account of, or in any way growing out of said activities, and hereby assume all risks of loss, damage, or personal injury, including death, that may be sustained by the Minor which may hereinafter occur on account of, or in any way growing out of said activities.**

This release and indemnification shall not be revokable. The duration of this release and indemnification shall be perpetual and not limited in time and shall release the Owner(s) and Operator(s) of Fields & Fences for future activities and injuries as well as activities and injuries taking place on the date hereof. The undersigned agrees to read all posted rules and warnings prior to each day's activities to advise the Minor of their contents and meaning and to require the Minor to abide by such posted rules and warnings at all times.

WARNING: Under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities (Senate Bill 240-IL).
